CHRISTIAN

It has been my honour and pleasure to be part of the International French School in Singapore continued evolution, development and expansion throughout 2020. Faced with unprecedented challenges during a global pandemic, the school has never-the-less endured and grown from the experience. 2020 saw many changes and adaptation to teaching and learning, strengthening and enhancing the schools' capacity to provide a prestigious, premium, bilingual, international, French education for students aged two to eighteen.

In 2020 the school undertook a significant evolution in its branding and image. For over fifty years, the Lycee Francais de Singapore had provided a French education of excellence to a mainly French expatriate community. In 2020, prompted by an ever-growing international population of students and the French government's goals to expand French educational offerings internationally, the school rebranded in February. It became the International French School (Singapore). A significant and definitive strategic move for an already well established and academically successful school.

Following the rebranding, the school was plunged into one of the most significant challenges it has faced in its long history. The onset of the COVID-19 global pandemic forced us to move to a "Home-Based Learning" (HBL) teaching method in April and May. HBL forced teachers to adapt their teaching style. It changed how IFS educators approach students, the subject matter, and how they captured students' attention. At IFS, we understood very quickly that it was an adjustment and a learning journey for teachers, students and parents.

A robust structured approach guided our HBL programme. We provided a critical continuity of education. For younger primary school students, we gradually introduced new content and concepts. We were giving students time to adjust to the new routine and giving our teachers time to adapt and evolve the programme. For older and more mature students, capable of more independent learning, we continued with the teaching of the curriculum. We guided our students carefully and methodically as many of them prepared for their final exams in a virtual teaching environment.

We drew a number of positive lessons from the HBL experience. 1. The importance of student awareness of safe internet use. 2. HBL required real discipline from the student in terms of managing their day and maintaining engagement. A skill for the future. 3. It taught students the impotence of the right balance of work, play, rest and a good sleep routine. 4. Making mistakes is essential and healthy in the learning process.

It gave me even more pride in our school when it became evident that the IFS Class of 2020 had overcome a challenging academic year with 93% receiving a "Mention" (merit), 55% high merit "Très Bien" in their final year Bac examinations. Once again, the International French School in Singapore showed its deserved position as one of the top academic institutions within the AEFE Asia-Pacific network and a top international school in Singapore. The excellent 2020 results were proof of the quality of our structured teaching and learning practices; our experienced, passionate, dedicated pedagogical staff; the culture of the IFS learning environment and the determination, character and maturity of our students. IFS continues to provide the opportunity for students to further their education at some of the top Universities throughout the world.

Despite the restrictions and disruptions caused by the COVID-19 pandemic, the school implemented several initiatives in 2020. Of note, in response to the COVID-19 global situation, IFS hosted for the first time a Summer Camp of enriching and educational activities for students aged four to seventeen years old. IFS offered over twenty-five different camp activities over four weeks. Some nine hundred students participated per week while maintaining safe-distancing and health protocols for COVID-19 prevention. Holiday camps have now become a notable fixture in the IFS educational offering.

For the start of the school year 2020-2021, the International French School (Singapore) reinforced its language offering for IFS students in Collège (grade 6 to 9) with the launch of a new language stream, "Mandarin Culture & Civilisation". This stream is an opportunity for IFS students to access a trilingual education; French, English and Mandarin. A new and exciting educational pathway accessible to all motivated middle-school (Collège) students starting from IFS Sixième (grade 6) interested in the world of China and wish to acquire a solid background in Chinese language and culture. A great initiative by the school that will bring further developments and opportunities to students in other grade levels in the future. At IFS, our vision for the school is to foster a learning experience that blends culture, structure and passion. Throughout 2020 this was tested to the limit. However, despite the difficulties and challenges, the school remained committed to making sure every student not only felt at home in a multicultural environment but was given the opportunities and support they needed to reach their full potential.







OUTSTANDING RESULTS AT ALL EXAMINATIONS



IFS Terminale students achieved a 100% pass rate with almost 80% receiving high merits (*Très Bien* and *Bien*). The class of 2020 achieved a 9 point increase on last year for top merit "*Très Bien*": from 46% in 2019 to 55% of students in 2020.

117 students participated in this modified 2020 examination process, with 18 students choosing to take the International Baccalaureate Option (OIB). Due to concerns over the coronavirus, the exams at the end of Terminale were replaced by other means of assessment. Notably regular progress checks in areas such as coursework and homework. It is the first time since its inception in 1808 under Napoleon Bonaparte that the "bac" exam has not taken place in its traditional form.

DNB (Diplôme National du Brevet):

174 students / pass rate 98.8%, with an outstanding 93.6% of students being awarded merits. 82% "Bien" (Good) and "Très Bien" (Very Good), 50.8% "Très Bien" (Very Good)

Due to the health situation faced globally with the COVID-19 pandemic, the written and oral tests of the 2020 Brevet were cancelled and replaced by continuous assessment in French, mathematics, history-geography and sciences. Thus, the DNB 2020 is obtained this year based on the average of the grades achieved in trimesters 1 and 2 and the common core competencies.

The 2020 DNB was marked on 700 points instead of 800. The points scale for the awarding of merits was revised (Merit Assez Bien: between 420 & 489 points / Merit Bien: between 490 & 559 points / Merit Très Bien: 560 points & over). To be awarded the collège certificate, students must have at least 350 points.

2020 COVID-19 HEALTH & SAFETY MEASURES

With the outbreak of the COVID-19 global pandemic, IFS put in place precautionary measures and procedures to ensure a high level of protection for students and staff:


When implementing the IFS home-based learning programme, we made sure the programme is adaptable to support student needs and ensure a smooth transition from a classroom environment to a home environment.

Governed by both an educational and an executive committee:

- **The Educational Committee**, headed by the Principal, examines everything that is related to school life, particularly teaching matters.
- The Executive Committee, headed by the President, oversees the management and long-term strategy of the School to the exclusion of purely pedagogical matters. All members are volunteers, they do not receive any financial compensation from the School for their activities. They are elected by the Members of International French School (Singapore) during the Ordinary General Meeting. The Executive Committee represents the community of parents as well as the companies that hold Options de Fondateur (ODF).





THE EXECUTIVE COMMITTEE

The Executive Committee is in charge of the organisational aspects of the school:

The Executive Committee (EC), manages the affairs and administration of the school, excluding the academic aspects. This committee is composed of 12 volunteer board members and up to 4 reserve members designated by the Members of International French School (Singapore) during the Ordinary General Meeting. No Executive Committee member receives any remuneration for their services. The EC is in charge of the long-term strategy of the school.

The Executive Committee is made up of 12 elected members and 4 reserve members (Corporate member: 2, Individual member: 2) from each group: Individual members and Corporate members. The members are elected by the General Meeting held each year in October or November.

The French Ambassador in Singapore and past President are honorary Presidents of the Executive Committee.

The EC is in charge of the long-term strategy of the

The EC delegates specific projects or missions to its standing committees and may from time to time create any such other committees as it may deem necessary.


The EC delegates the day-to-day management to the Executive Director, Yves Marcel (appointed in March 2015) who reports functionally to the Principal.

The Counsellor for Culture, Education and Science, Embassy of France in Singapore (COCAC) is a nonvoting member.







CHARITY STATUS - RESERVE POLICY

Overall, the total surplus amounted to 5.7M, including a COVID-19 grant of 0.16M SGD from AEFE and donations of 0.3M SGD from ODF companies.

Reserves are intended to ensure the school's sustainability. The operating reserves provide a backstop in case of an unexpected decline in enrolment and underpin the long term facilities plan such as infrastructure upgrades and campus expansion.

Due to this favourable surplus, IFS ended the year 2020 with reserves of 85M SGD.

The healthy state of the school's finances reflects the continuous efforts of the Board and the Administration to maintain and improve the school's long term financial sustainability. The Management looks forward to an exciting future for the International French School (Singapore).

REVENUES

We are pleased to report that our audited financial results for 2020 compare favourably to the budget approved by the Executive Committee in November 2019 for both revenues and expenses.

The principal funding source of the International French School (Singapore) derives from the school fees.


Revenue, after one-off COVID-19 adjustments, is in line with the budget.

The school continues to experience organic growth thanks to the international pathway. There were, on average, 2,953 students in 2020.

As a result, the 2020 turnover amounted to 65.9m, a 0.3% increase compared to 2019.

In June 2020, an IFS COVID-19 Solidarity Fund was created, as short-term relief, to support families who have been most affected economically by the ongoing pandemic.


In the past year, 22 families and 40 children have benefitted from this fund.





EXPENDITURES

- Operating expenses were lower than budgeted due to the constant focus on renegotiations of significant contracts and tight
- > COVID-19 further contributed to this through events that had to be held virtually and unrealised school trips. However, the school spent more on Health and Safety measures.
- > Personnel costs, the school's main expense, were also lower due to later recruitments, optimisation of our exchange policy and the Job Support Scheme from the Singapore government to help with the COVID-19 situation.
- > The financial result was also positive due to the deferment of the school construction project due to COVID-19 and the uncertainty it brought.
