



TERMS AND CONDITIONS

The Lucky Draw of the IFS School Fair 2026 ("Draw") is organized by International French School (Singapore) Ltd ("IFS"), having its registered office at 2900 Ang Mo Kio Avenue 3 Singapore 569928.

- Participants must be an IFS student's parents & family members, an IFS Staff, residing in Singapore aged 18 years and above.
- Each eligible participant will be provided a ticket ("Ticket") corresponding to their name and a unique serial number.
- IFS staff are allowed to participate in the Lucky draw.
- Participants must comply with the terms and conditions set forth herein to be eligible for the Draw.
- Lucky draw ticket sales are from May 14 to June 20, 2026.
- Lucky draw ticket sales will cease on June 20, 2026, at 1 pm.
- No Lucky draw ticket sales transactions to occur after the set deadline.
- The lucky draw will commence on June 20, 2026 between 2 pm and 4 pm.
- A third party other than the event organizers will do the actual draw.
- The actual draw will be supervised by the school's legal representative/personnel of the same capacity.
- The winning ticket will be announced by its ticket number only.
- Each winning ticket will be validated and recorded.
- Prizes are available to claim on the same day.

The original winning ticket must be presented to claim any prize. The acceptance of any alternative form of proof shall be at the sole discretion of the School Fair Committee, whose decision shall be final and binding.

- Prizes are non-transferable and non-exchangeable for cash or other items.
- Vouchers & gift certificates are governed by their validity and terms & conditions.
- Winning ticket numbers will be posted on the website on the School fair dedicated event page. It is the **participant's responsibility to check the winning ticket number(s)**. Email notification is only for major prizes if the prize(s) remains unclaimed within three (3) working days post event.
- **Prize collection will take place at the school from June 23 to June 26, 2026 between 8:15 AM and 12:00 PM. Please note that the final deadline to collect your prizes is June 26, 2026, at 12:00 PM.**

- Prizes must be collected in person; no prizes will be home-delivered.
- Prizes shall be claimed solely by the eligible winner. Should an authorized representative claim the prize on the winner's behalf, a duly executed authorization letter signed by the winner, together with the original winning ticket, must be presented at the time of collection. Failure to comply with these requirements may result in forfeiture of the prize, at the sole discretion of the School Fair Committee.
- Claiming prizes after the deadline will not be entertained.
 - Participants agree that personal data provided will be used for the purpose of administering the Draw and in accordance with the Personal Data Protection Act 2012.
 - IFS reserves the right to amend these terms and conditions at any time without prior notice.
 - IFS's decisions on all matters relating to the Draw will be final and binding.
 - By participating in the Draw, participants agree to be bound by these terms and conditions.
